
GROUP D: OKLAHOMA CITY CHAPTER

PAST NATIONAL PRESIDENT, LISA CASIAS, CPA, RECEIVES KING AWARD



Discuss your journey as an AGA volunteer and what you have gotten out of it personally and professionally.

I joined AGA early in my career, but did not become active as an AGA volunteer until I served as the Washington, DC Chapter president. It was one of the best decisions that I have made in my financial management career. I was able to meet so many people in other agencies that I would not have met through the normal course of business. I was motivated by the volunteers in the chapter; their enthusiasm and willingness to serve the chapter was unbelievable. My initial concerns about having too little time to spend on chapter activities was unfounded due to the many volunteers who worked together to make things happen. I would encourage all AGA members to explore volunteer experiences within their chapter.

Although I thought serving at the chapter level would be a difficult experience to beat, serving as the National President provided additional opportunities to enhance both my personal and professional skills. AGA plays a critical role in government financial management and accountability, and being afforded the opportunity to make a difference as part of this organization was an honor. The organization provides so many benefits to its members and to the furtherance of our profession.

What is your proudest moment as an active member of AGA?

My proudest moment as part of AGA was the passing of the revised strategic plan at the 2011 National Board of Director's meeting. It was a collaborative effort of leaders throughout the Association and was based on the input

from all of AGA's members. It positions AGA to 1) continue current valued activities, 2) take advantage of new opportunities, and 3) provide AGA's member leaders with direction for continued success and growth. Another critical area was the establishment of a chapter and regional governance task force that analyzed the regional governance structure and chapter alignment. It was a decade since the previous structure was established and since that time, AGA and its demographics had changed and were significantly different. A revised structure was proposed and approved by the National Executive Committee.

While these were important achievements in the association, the most rewarding experience was interacting with members across the association. The dedication of the many volunteers that make AGA the premiere organization that it is today is incredible. At a time when there are many hardships on government employees from furloughs to frozen pay and benefits, it was clear to me over my travels the true meaning of public service.
